This is a clarification on the program status at Catalyst College, Patna, during the academic year 2018-19 and addresses an oversight in our Institutional Information for Quality Assessment (IIQA) submission.

Catalyst College, Patna, was affiliated with Magadh University for the academic year 2018-19. Due to a bifurcation initiated by the Government of Bihar (vide letter no. 15/M1-71/2016-700, dated 09.04.2018), the college's affiliation shifted to Patliputra University starting in 2019-20. Accordingly, 180 students were present in the academic year 2018-19 under Magadh University affiliation continued their programs into their third years. No new admissions were taken due to transition period and it was differed fir the Session 2018-19.

However, the college inadvertently missed including these specific details in the IIQA submission. We respectfully request your kind consideration of this oversight and acknowledgment of the program continuity for the assessment year 2018-19.

The College is providing year wise academic data in the prescribed template, mentioning the name of students, name and year of the program, academic year of the student and the respective affiliated University.

The admission process continued from Session 2019-20 under the Affiliation of Patliputra University, Patna.

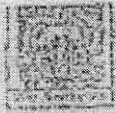

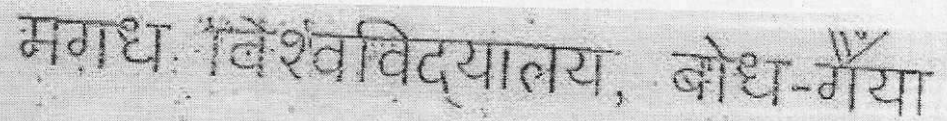
